Administrator's computer is the official time keeping device for the receipt of entries for the Contest. - **2. AGREEMENT TO OFFICIAL RULES**: By participating in the Contest, entrants (also referred to as "you" or "your") fully and unconditionally agree to and accept these Official Rules and the decisions of the Sponsor and Administrator, which are final and binding in all matters related to the Contest.

- b. If utilizing the AfterShot Pro 3 Software, edit a digital photograph of your own to create an "After" photo; if not utilizing the AfterShot Pro 3 Software, simply choose your best "After" photo.
- c. Upload the "After" photo to http://digital-photography-school.com/corel-aftershot-pro-contest/ a description of how you feel Corel AfterShot Pro 3 would help your photography; the photo and written description together constitutes an "Entry".

Your Entry must meet the following criteria:

• The "After" photo must be in the following formats: JPEG, non-animated GIF, TIFF, and PNG;

- a. On or about July 25, 2016 ten (10) winners will be selected by a Corel judging panel, from all eligible Entries received during the Contest Promotion Period, based chiefly on the following criteria:
 - Originality & WOW factor: Does it grab the viewer's attention and leave them saying "WOW?"; is it memorable, does it use elements that are original?;
 - ii) Creativity: Does the photo have a good balance of creativity and emotion; is the content portrayed in a creative way; does the photographer make use of creative photo editing techniques?;
 - iii) Composition & Layout Is the visual balance of the photo pleasing to the eye, and abiding by the basic principles of composition?
